This package includes the ACI Craftsman Workbook (CP-1005), a 2-3 hour review session, and the written exam. In order to obtain the Flatwork Finisher Certification an applicant must pass the written exam and must turn in a minimum of 4,500 hours of approved work experience using a form to be provided (note - the Arizona Chapter does not currently conduct any performance exams). Applicants who do not possess 4,500 of field experience, but who pass the written exam, will be awarded certification as a Flatwork Technician. This package includes the ACI Tilt-Up Supervisor and Technician Reference Guide (CP5007), a 2-3 hour review session, and the written exam. In order to obtain the Tilt-Up Supervisor Certification an applicant must pass the written exam and must turn in a minimum of 7,500 hours of approved work experience using a form to be provided (note - see ACI requirements regarding work experience requirements at the web site listed below). Applicants who do not possess 7,500 of approved field experience, but who pass the written exam, will be awarded certification as a Tilt-Up Technician.
